The City Council met in regular session in the Council Room in the Municipal Building. Present on Roll Call were Mayor Amiel Redfish and Council Members: Curt Lundquist, Terry Rowbotham, Jesse Steffensen, Rob Achterberg and Cory Falconer. Absent: Garth Johnson.

Austin Brandt submitted a revised building permit application for a 32 X 44 foot shed with 10 foot sidewalls to be placed in the same location as the previously proposed building at the S 214' of W 185' of OL 3, SESE 36-111-53 in County Auditors Plat of Outlots--210 W Poplar Street.

Motion was made by Steffensen, seconded by Achterberg to approve the building permit for a shed that is built within the size limits of the zoning ordinance. All in favor—Carried.

The Finance Officer had received 3 quotes to remove the wall in the fire hall and extend the bays back into the community room portion of the building. The quotes received were from:

Ryco Construction--\$20,194.50 (\$17,894.50 if the HVAC & Electric are omitted)

Steffensen Construction--\$18,775.00

Bunker Construction--\$25,829.95

Motion was made by Rowbotham, seconded by Achterberg to accept the low bid from Ryco Construction. All in favor—Carried.

The council reviewed the applications that had been received for seasonal employment and Motion was made by Lundquist, seconded by Falconer—the following individuals are being offered positions. All in favor—Carried. Cemetery Caretakers--Lonnie Johnson (\$13.25/Hr) and Les Rowen (\$12.25/Hr); General Mowing—David Wingle (\$12.75/Hr), Gene Wiehr (\$12.25/Hr) and Steven Monteith (\$13.25/Hr); Painters/City Crew—Will Parry (\$10.75/Hr) and Devon Heuer (\$10.25/Hr).

Swimming Pool: Co-Managers/Lifeguards—Braxton Donley and Machaela Baker (\$12.25/Hr); Lifeguards—Miguel Campos (\$11.25/Hr), Dyland Geary, Jael Lundquist, Avery Meyer and Lynsey Stevens (11.00/Hr)—must obtain their lifeguard certifications. Bath House Workers—Victoria Donovan (\$9.75/Hr) and Christian Virchow (\$9.00/Hr).

Motion was made by Steffensen, seconded by Rowbotham to enter into executive session at 7:19 P.M. for contract matters and personnel. All in favor—Carried.

Motion was made by Achterberg, seconded by Lundquist to come out of executive session at 7:46 P.M. All in favor—Carried.

The decision was made by the council to pay for the recent property damage claim in the amount of \$599.06 rather than to submit it to the insurance company for payment

Motion to adjourn was made by Falconer, seconded by Rowbotham. All in favor—Carried.
